# **313@somerset Tourist Exclusive Promotions**

# **Terms and Conditions**

## 1) 313 Tourist Pass

1 April 2024 to 31 March 2025 (both dates inclusive)

- a) Tourists are eligible to redeem one (1) 313 Tourist Pass by presenting their <u>non-Singaporean</u> <u>passports</u> at the B1 Concierge Desk to enrol in 313 Tourist Programme.
- b) Tourists are required to present 313 Tourist Pass and their <u>non-Singaporean passports</u> at point of purchase to qualify for Tourist Privileges at participating stores.
- c) 313 Tourist Pass is valid for 7 days from date of issue.
- d) Each tourist is entitled to only one (1) valid 313 Tourist Pass at any one time.
- e) Tourist Privileges at participating stores are not applicable in conjunction with other promotional offers, discounts, vouchers, privileges and sales items.
- f) Tourist Privileges at participating stores are valid while stocks last and subject to change without prior notice, at the discretion of participating retailers and 313@somerset.
